Citizen 3 asked about having a study being done for RT 177 to see if there is the need to reduce speed limit to 35mph to slow traffic down. He also asks who is responsible for maintaining the Road. The Commission explained that The State of Kentucky is in charge of maintaining RT 177 and suggested that as citizens, they should put a petition together and to contact our State Representative. Citizen 4 ask what to do about Feiser Road slipping down the hill, it was discussed that this has been taken to District 6 since this is a County issue. Citizen 2 ask also about Locust Pike and the oversized emergency pothole and very rough road. It was again advised that this is a State Road and has been brought to District 6's attention but recommended that the citizens petition the State for immediate services on Locust Pike State owned portion of the road. He was directed to contact the county.
