Park(s) amenities have been evaluated for ways to make the parks more attractive to citizen(s) usage. Plan is to use some of the funds still available to add a 12'x21' shelter with a concrete base. Gills donated by the county parks department will be added to the shelter area. Prices and providers are being gatherer for port-a-potty services, including those with handicap capabilities.

**Roads Report** – Meetings in progress with county roads department. Awaiting for road work to begin this week. Work has been contracted with Riegler. The roads department has contracted with Riegler The "20 gallon garbage can" sized hole reported by a citizen as last month's meeting investigated and determined to have been exaggerated. It was only the first layer of blacktop had peeled off about a foot and a half deep in diameter.

Veterans Affairs Committee – Costs are still being evaluated to make corrections to the monument plus to expand the memorial.

An Ordinance Adopting the Annual Budget for the Fiscal Year July 2019 through June 2020, stating Estimated Revenue, Resources and Appropriating Funds for the Operation of the Ryland Heights City Government according to KRS 91A.030.

## NOW THEREFORE THE CITY OF RYLAND HEIGHTS, KENTON COUNTY, KENTUCKY DOES ORDAIN AS FOLLOWS:

### SECTION I
